### **Nomination Qualifications**

Nominees must be a living resident of Henderson County. Committees, corporations and organizations are not eligible for the Award.

Recipients exemplify selfless volunteer leadership in philanthropic work for our community’s greater good, remaining engaged with commitment and determination to accomplish results that will help others and create a better future even beyond our lifetime. They continue to advocate positive results and champion the achievement of excellence for everyone to become their best self while supporting our becoming the best community for all. If the Nominee is employed by a nonprofit their efforts must go above and beyond the scope of their job.
